are here to help people through their darkest times," says David Jason Cohen, head of the criminal defense department and managing partner at Cohen Forman Barone, PC. "As a former prosecutor, I've seen the government use its power to bully people into taking responsibility for things they didn't do. Our job is to protect and enforce our clients' rights by resolving matters before charges are filed, negotiating for the dismissal of charges, or fighting those charges in court."

Early in his career, Cohen served as an assistant district attorney in Kings County. He worked with a team of investigators, often visiting crime scenes mere moments after the crime took place. While this experience gave him an intimate understanding of the criminal investigations, it also opened his eyes to the fundamental inequalities in the criminal justice system.

"What I saw at the district attorney's office bothered me so much that I left," Cohen says. "I switched sides and became a public defender."

After a nine-year stint with the public defender's office, Cohen joined forces with longtime colleague, Cory Forman. Carla Barone joined the team as a partner nine years after the firm's founding to become

head of matrimonial and family law. As the head of the firm's criminal defense team, much of Cohen's practice involves defending white-collar workers swept up in complex federal prosecutions—for many of whom it is their first run in with law enforcement.

"When someone is being investigated for a crime, their biggest concern is usually staying out of prison," Cohen explains. "Many of my clients are highly respected professionals, executives, and entrepreneurs who have never been in trouble before. It can be an overwhelming ordeal, where even an innocent person can feel pressured to take a felony deal. I am not just defending the rights of my clients, but also their licenses, careers, and reputations, because their whole world is at stake. And it's not just the client, I am defending their families, their futures, and their dignity."

"It doesn't matter if I'm defending a blue-collar worker or a CEO, I'm helping the little guy every time," Cohen says. "Everyone is the little guy when the U.S. government—or a local state governmental agency like the district attorney's office—is coming after them. I'm never on the wrong side of a case, because I am defending my clients against the most powerful bureaucratic institutions in the world."

By speaking directly to the concerns and priorities of investigators, Cohen can resolve cases before any charges are filed. When this isn't possible, however, he's ready to fight for his clients in the courtroom.

"I've been a trial attorney for over 30 years," Cohen notes. "I'm always the most prepared person in the courtroom. If I need to be a bulldog and tear witness testimony apart in cross examination, I can do that. If the situation calls for a more docile approach and less confrontation, I am more than capable of handling it that way as well. I have access to a team of experts in fields ranging from forensic accounting to crime reconstruction. More importantly, I've seen it all. Whatever issues the client is facing, or how serious the charges are, I've handled it before."
